- (1) Please keep your approved Application and signed Liability Waiver with you during your event.**
- (2) You will need to supply your own hoses. Hoses must be equipped with trigger style spray nozzles that shut off automatically when water is not in use.**
- (3) Bring a pair of pliers with you to turn on the water. The faucet you will use is located on the grassy meridian between the parking lot and bridge over the highway.**
- (4) If the water does not flow, it may have been shut off at the backflow device due to irrigation issues. You can find the backflow device next to the McDonalds drive-thru. Once you open the valve there, you should get water to flow from the faucet.**
